do hereby undertake that as a hosteller at LDAH Rajkiya Engineering College Mainpuri:

1. I will follow the code of conduct/rules relating to the hostels as formulated by the college.
2. I shall keep the hostel room allotted to me and the premises clean and hygienic and will make it available for periodic cleaning and inspection as required.
3. If any damage is caused to the building, furniture, fittings, electrical appliances etc., I will be responsible and charges/fine for repairs and / or replacements will be collected from me or deducted from my caution money of hostel.
